

Businesses will be responsible for the waste collected on and transported from their premises, meaning dry recyclables (which can be grouped together), food waste, and general waste must be separated.



Businesses will not be able to use food waste disposal equipment (for example macerators) or other forms of food waste treatment equipment (for example dewatering or enzyme digesters) to discharge food waste or liquid derived from food waste to a drain or sewer.
